# SOLENIS POLICY Sustainability

# 1.0 Policy

Solenis will conduct business in a sustainable manner in compliance with all applicable environmental, health, safety and security laws, regulations, technical specifications and internal standards, while adhering to high ethical standards and commitment to respecting human rights. The health and safety of our workers, customers and communities, as well as the prevention of environmental harm, are among Solenis' primary responsibilities.

## 1.1 Objective

To outline our commitment to ethics and compliance, continuous improvement, environmental stewardship, diversity, equity and inclusion, human rights, security and worker health and safety across our entire enterprise.

## 1.2 Our promise

Solenis is committed to continuously improving our business operations and providing safe working conditions for our workers. We are also committed to the design and development of sustainable solutions, including safe use and handling of our products.

Our environmental efforts support the sustainable production, use and disposal of all Solenis products. We also work toward environmental, health, safety and security excellence as an integral part of our management systems. We work to be an industry leader in these areas and are committed to operating our global facilities and businesses in accordance with the principles of Responsible Care\*. Solenis' commitments to the environment, Responsible Care, health, safety and security are outlined in our Responsible Care policy, SL-POL-005.000. Solenis treats resources in a responsible manner to eliminate waste and improve operational efficiency. Each worker is expected to promote these goals in his or her tasks. All employees are expected to use Solenis resources in a responsible manner to eliminate waste.

#### 2.0 Commitments

#### 2.1 Health and safety

Solenis commits to providing workers with a safe, healthy and hygienic working environment, including, but not limited to, safe driving and parking practices, adequate emergency procedures,

fire safety, management of hazardous materials and housekeeping. Where legal requirements for occupational safety do not exist, Solenis will ensure the safety and well-being of workers by employing best practices for health and safety, including, but not limited to, training and incident prevention initiatives. Solenis' long-term ambition is to operate with zero harm; one incident is too many.

# 2.2 Sustainability

Solenis commits to operating in a sustainable manner by evaluating and improving our social and environmental impacts. On a regular basis, Solenis will conduct a materiality assessment to identify the key environmental and social issues for our business. Solenis will integrate sustainability targets on these material issues into company objectives, embrace best practices, communicate our results to stakeholders and publish a Sustainability Report on a regular basis. ## 2.3 Ethics and compliance

We conduct business consistent with our core values of respect, integrity and accountability across all our operations around the world, without exception. We compete and conduct business based only on the distinction and quality of our products and services, and the value we deliver to our customers. Our <u>Global Standards of Business Conduct</u> (the Code) underpins our Deliberate Ethics<sup>SM</sup> Culture. Each year, each employee will certify adherence to these standards and that they are not aware of any violations of our Global Standards of Business Conduct. The document is available in 22 languages in the Sustainability and Regulatory Library on solenis.com.

## 2.4 Transparency

We maintain an open and active dialogue with our workers and communities about environmental, health, safety, security and product stewardship issues. We work with governments, policymakers, advocacy groups and value-chain partners to develop and promote laws, regulations and practices that improve human health and the environment. Solenis will report progress on our management of the material sustainability issues regularly.

#### 2.5 Environmental stewardship

Solenis commits to compliance with all applicable environmental regulations where we manufacture, sell or distribute products. Environmental permits will be kept current and followed. Where no local regulations exist, we will operate in a manner that does not pose risks to the environment. Our facilities are operated to reduce our impacts and improve our overall environmental performance. A key focus is the reduction of environmental incidents that may arise from chemical releases. New facilities added through mergers and acquisitions are introduced to our Responsible Care certification process through our integration efforts. In addition, we are committed to certification of all global manufacturing plants to RC14001 certification. Responsible Care policy, SL-POL-005.000.

#### In addition:

Climate change and energy management – Solenis recognizes the threat that climate



change poses and will take appropriate action to mitigate our impact. Solenis commits to Net Zero emissions by 2050. Solenis takes action and manages impacts by working with our stakeholders and combining energy-related investments with efficient manufacturing best practices.

- Water management and stewardship We are committed to responsible water stewardship by actively assessing and managing our water-related risks. Our approach incudes reducing once through water and withdrawals from natural sources such as surface water, groundwater, and wells; minimizing overall water consumption across our operations and operating our wastewater treatment systems efficiently to prevent pollution. Additionally, we are working to phase out the use of hazardous substances that may impact water quality.
- Air emissions management We are committed to minimizing our impact on air quality by actively reducing emissions of nitrogen oxides (NOx), sulfur oxides (SOx), and volatile organic compounds (VOCs) across our operations.
- Protection of biodiversity and ecosystems We are cimmitted to preserving biodiversity
  and protecting ecosystems across all areas of our operations. We carry out environmental
  impacts assessment and prioritize the avoidance of negative impacts on threatened and
  protected species. We respect all legally designated protected areas and ensure our
  activities are aligned with conservation objectives.
- Waste management In our manufacturing sites, we have implemented processes to reduce, recycle and reuse materials that potentially can become waste.

## 2.6 Security

Solenis commits to maintaining and securing the physical work environments, including but not limited to physical security measures, access control, information technology and cyber security, response to security threats and security incidents, and a security continuous improvement process. #### 2.7 Product Stewardship

Solenis commits to ensuring our products are safe for their intended uses. Risks to human health or the environment associated with the use of Solenis products must be negligible. Products must comply with all applicable regulations where they are manufactured, sold or distributed. Products must be supported by safety information including, but not limited to, appropriate directions for use, hazard classifications, warnings, first aid instructions and emergency contact information. Accurate and complete Safety Data Sheets and labels must be legible and available to distributors, customers and end users.

Solenis also commits to responsible material use. See Responsible Chemistry Policy, SL-POL-010.002; Sustainable Procurement of Raw Materials, SL-POL-008.005; Responsible Palm Oil Sourcing, SL-POL-008.012, and Conflict Minerals, SL-POL-008.012.

#### 2.8 Supplier engagement

Solenis commits to engaging and collaborating with suppliers to ensure they are complying with environmental regulations and not posing risks to the environment. Suppliers are expected to have all applicable environmental permits in place. See <u>Supplier Code of Conduct</u>, <u>SL-POL-008.007</u>,



<u>Conflict Minerals, SL-POL-008.012</u> and <u>Procurement Sourcing, SL-POL-008.000</u>. Solenis also commits to engaging and collaborating with suppliers on key social and governance issues, such as, but not limited to, modern slavery, ethical business practices and anti-discrimination activities.

## 2.9 Equal opportunity and non-discrimination

Solenis is an employer committed to fair and equitable practices and opportunity for all people, and commits to a workplace free of discrimination, harassment and retaliation. We create a workplace culture where all employees are provided with growth and development opportunities, providing long-term career paths to all employees. We promote two-way dialogue with our employees individually and through collective representatives; and support Employee Business Resource Groups to enhance engagement and belonging.

## 2.10 Social and human rights

We focus on upholding and promoting human, employment and labor rights in all aspects of our business and protecting the rights and interests of all our stakeholders, individually and collectively. Solenis has adopted the norms and principles in the Universal Declaration of Human Rights and other international Human Rights frameworks. See Human Rights, SL-POL-004.030

#### 2.11 Governance

We are committed to develop and implement our positions on sustainability and monitor global developments and sustainability trends to ensure that Solenis' efforts remain relevant, competitive and compliant with governmental requirements. In addition, through our governance structure, the company monitors and facilitates progress to ensure consistency with our strategy, goals and reporting standards. We will report regularly to senior leadership and our governing bodies on our strategy and progress in these areas.

A core component of our governance framework involves industry benchmarking, and establishing and maintaining relationships with external authorities, government agencies, regulatory bodies, industry representatives, customers, and other parties while representing and protecting our business interests in the external environment.

The governance structure is subject to the compliance obligations under <u>Solenis' Global Standards</u> <u>of Business Conduct</u>, including the reporting of any potential concern.

## 3.0 Use and maintenance of this policy

This policy will be communicated to all employees and made available at all Solenis sites. The Environmental, Health and Safety department and Corporate Sustainability team will review this policy on a timely basis, at least once per year. Updates will be made to ensure the policy reflects best practices for sustainability.

Any violation or potential of this policy should be reported to management, the Human Resources Department, the Legal Department, the Office of Ethics and Compliance, or a report be submitted via the Share Your Concern Portal, available on Solenis' intranet page and website.



# 4.0 Scope

This policy covers all Solenis businesses, subsidiaries, offices, warehouses, manufacturing facilities and operations globally. Compliance with this policy is the responsibility of every worker worldwide and is a condition of employment. Managers will lead by example as well as educate and train workers and stakeholders. Everyone must commit to the safety of themselves, coworkers, visitors and customers. Anyone concerned about a work-related situation should stop the activity and report it as unsafe to their manager, who will lead finding a safe approach.
